Memorandum of Understanding

This agreement is made at Mahendergarh on this 30 day of April, 2021 (hereinafter referred to as the "Memorandum of Understanding")

BY AND BETWEEN

Central University of Haryana, Mahendergarh, an educational institute established by an Act of Parliament located at Jant-Pali, Mahendergarh, Haryana, represented by its authorized signatory hereinafter referred to as "University" (which expression shall unless repugnant to the context thereof mean and include its successors-in-interest and permitted assignees).

AND

Sheela Multi-Superspeciality Hospital, near new BSNL Exchange, Mahendergarh and represented by its authorized signatory, Dr, Prashant Jangra, (hereinafter referred to as "Hospital" (which expression shall unless repugnant to the context thereof mean and include its successors-in-interest and permitted assignees).

Effective Date:

The Parties hereby agree that the Effective date of the Agreement shall be the date on which the agreement is signed and is valid for one year. The agreement may be extended on need basis for further period as deemed fit by the University on the same terms and conditions.

WHEREAS

The Hospital will provide the following services to the university.

1. One duty doctor 10:00 AM to 04:00 PM (except on Sunday & festival holidays)
2. One Nursing staff round the clock.

3. Consultation visit of specialist i.e. ENT, Gynae, Pediatric, Dental, at least 02 hours on a particular day in week as fixed by mutual arrangement.
4. No consultation fee will be charged to staff, their family members and students during hospital visits.
5. If patient is sick and need for admission, ambulance (by Central University of Haryana) will take the patient to hospital of the service provider/any hospital referred by the service provider where patient is to get treatment as per requirement.
6. Rates/charges for treatment and other expenses will be charged by the Hospital of the Service provider as agreed between the parties i.e. Rs. 1,50,000/- (Rupees one lakh fifty thousand only), per month.

WHEREAS

- A. The "Hospital" will provide the medical services as per the laid down norms of Medical Council of India and Nursing Council of India.
- B. The "Hospital" will submit to the "University" the certified copies of the valid Professional degrees of the Medical Officer (Doctor) and the Nursing Staff deployed at the University. The "Hospital" will provide the Bio data of the staff deployed at the University.
- C. The provider undertakes to provide the service in a meticulous, precise, reliable, professional manner and at the highest level of service, to the complete satisfaction of the "University" and in accordance with additional instructions to be issued from time to time by the "University" and brought to the attention of the provider (Hospital).
- D. The provider (Hospital) shall treat beneficiaries in a courteous manner and according to good business practices.
- E. The "Hospital" shall be responsible for the conduct and behavior of the staff deployed at the University. The staff deployed shall maintain high standards of the discipline as the laid down rules of the University.

Declaration:

- A. The authorized signatory of Hospital declares and undertakes that it has all the registrations/licenses/approvals/authorizations required by law in order to

provide the services pursuant to this agreement and that he has the skills, knowledge and experience required in order to provide the service as required in this agreement.

- B. The authorized signatory of Hospital i.e. Service Provider undertakes to uphold all of the requirements of the law in so far as these apply to him and in accordance with the provisions of the law and the regulations, which are enacted, from time to time, by the local bodies/by the Central or State government, including a complete system to dispose of Bio-Medical Waste.
- C. The authorized signatory of Hospital i.e. Service Provider declares that he has never been barred from practicing medicine.

Period of Agreement/Termination

- A. The period of agreement will be one year and will remain in force until terminated. The agreement may be terminated by either party by giving to the other not less than 30 days prior notice.
- B. In case of the extension of the period of agreement, it shall be made on the same terms of the original agreement, unless it is otherwise expressly agreed between the parties in writing.

Terms & conditions of Payment

- A. The "University" agrees to pay all the eligible bills within 30 days of the receipt of bill on satisfactory performance of service. The payment will be made through Cheque/RTGS/NEFT or through any digital mode only to the "Hospital". Taxes at Source will be deducted from the Bills as per the rules of the Government of India.
- B. In Case of deficiency of services, necessary deductions will be made by the "University" as per the laid down rules of the University.

Jurisdiction & Arbitration of disputes

Any Disputes, claim arising out of this Agreement shall be resolved by mutual resolution. Any amendments in the clauses of the Agreement can be affected as an addendum, after the written approval from both the parties.


