

University is the highest temple of learning. It prepares, teaches and enables its students not only to dream big but also provides wings to their dreams and empowers them to realize their dreams. The entire fraternity of Central University of Haryana is putting its heart and soul in performance of this pious duty for the fulfillment of its sacred obligation towards its most important stakeholders, the students.

From its humble origin at a temporary campus in Namaul and making a modest beginning with three departments offering only Ph.D. courses, Central University of Haryana (CUH) has in a short span of seven years taken determined strides to offer a holistic learning experience to its entire student community. CUH today offers Masters, M. Phil. and Doctoral courses in over twenty-five disciplines through its nine schools spanning twenty-five departments. The University aspires to position itself as a premier institute at the forefront of Academics and Research by creating new paradigms in teaching-learning pedagogy, exploring new areas in the field of Research and Innovation by building partnerships with Industry and Research Institutions. As part of its ambitious expansion plans and catering to its social responsibility for providing quality education and imparting life skills, the University is in the process of starting two new schools viz. School of Education and School of Engineering. School of Education will offer B.Ed. and M. Ed. Courses and School of Engineering proposes to offer Engineering courses in four branches: Civil Engineering, Computer Science Engineering, Electrical Engineering and Printing and Packaging Technology.

In order to achieve the objectives of Skill India, Swachh Bharat Abhiyan and Make in India as espoused by our Honourable Prime Minister Shri Narendra Modi Ji, Central

University of Haryana has undertaken a number of initiatives through its various Centers, Cells and Clubs and has also started three B.Voc. Programmes: Retail and Logistics Management, Industrial Waste Management and Biomedical Techniques and also a Training-cum-Incubation Centre for Skill Development, Innovation and Entrepreneurship. The University is actively working towards creating synergies between Academics, Industry and Society to contribute significantly in the evolution of the nation and its people by acting as custodians of their trust, aspirations and inspiration. As an inclusive learning space, Central University of Haryana is poised for this socially responsible academic and research leap. The University has adopted eight of its neighbouring villages as part of its social responsibility and is proactively engaging with the local community at different levels to usher in a systemic change for rapid growth and development of these villages and the entire region. University has also started a Creche for the children of the workers at the construction site and plans to extend its facility for the staff and research students of the University and the people of the neighboring villages also.

At CUH we are constantly striving to open new vistas of knowledge and employment and create synergies utilizing the existing strength and building capabilities in new and cutting edge areas of academics and research. Through innovations in curricula and collaboration with other academic and research institutions, University is making rigorous efforts to optimize the outcome of the entire teaching-learning delivery mechanism. Focus has been on developing a 'learner-centric' approach in pedagogy, which caters to the diverse needs of the students. Towards this end, 'handson' training, e-learning, innovative discipline centric and inter-disciplinary experiments and industry-linked project work will be given a major push. The curricula and courses are being designed and updated in collaboration with industry partners in tune with Choice Based Credit System (CBCS), National Skills Qualification Framework (NSQF) and National Vocational Education Qualification Framework (NSVEQF). The fruitification of all these efforts has been in CUH completely implementing CBCS from the last academic session across all its courses and disciplines. The University boasts of a fully automated library with quality volumes of text, reference books and journals apart from providing the entire umbrella of e-resources under National Digital Library (NDL) and Information and Library Network (INFLIBNET). CUH is a registered partner of NDL.

It is firmly believed that a University striving to be a leader in Academics and Research must have suitable supporting infrastructure. Hence one of the key focus areas of development at CUH is the infrastructure. All the Departments of the University are scheduled to start functioning w.e. f. Session 2016-17 from its three new state of the art centrally air-conditioned Academic Blocks equipped with Seminar rooms, Conference rooms, a Moot Court of the Law Department, Studio in Department of Journalism and Mass Communication, Research Laboratories for the Science and Applied Science Departments, Food and Services Lab and Restaurant of Department of Tourism and Hotel Management. At present the University has completely Wi-Fi enabled four functional buildings, moderate accommodation for staff, separate

hostels and gymnasium facility for boys and girls, hotline electricity connection, solar-heating facility, on-campus branch of Punjab National Bank and Post Office, University Bus Service, Health and Insurance Policy for students, University-level scholarship schemes like Earn While You Learn and Merit-Cum Means, Reading Halls, Recreation Rooms are already in place and fully functional.

Apart from this the University has prepared an ambitious blueprint for developing its additional Academic Blocks, Administrative Blocks, Library, Hostel for Girls, fully equipped Dispensary and Health Center, Wi-Fi park, permanent staff quarters for teaching, non-teaching and administrative staff and Solar Electricity Power Generating Unit for the University.

In order to provide thrust and impetus to research and academics the University has entered into various Memorandums of Understanding (MOU's) with different Industry and Research Institutions for conducting collaborative research to explore new frontiers of knowledge. Such endeavours have helped in creating academic and research spaces, which encourage free exchange of thoughts and crossfertilization of ideas and knowledge. Towards furthering this objective the University is actively partnering in different schemes of MHRD and UGC like Global Initiatives of Academic Networks (GIAN) and Massive Open Online Courses (MOOCs). The University has prepared a robust and well deliberated roadmap for developing and launching GIAN courses and MOOCs. It gives me immense pleasure to share with all of you that five of the GIAN courses proposed by the University have been accepted after rigorous review while one of them will be conducted during this summer break. The journey of CUH till now has not been without its fair share of trials, tribulations and hardships. It has taken the toil and sweat of all the stakeholders of the University particularly its teaching, non-teaching, administrative staff and students to shape its destiny and bring it to its present stature. I would fail in my duty if I do not acknowledge the contribution of all its stakeholders who, in their own ways, have contributed to the growth of the University over time. I thank the students, staff and faculty members for their collective efforts and humbly acknowledge the contribution of all the former Vice Chancellors and the University authorities for shaping the administrative, academic and research trajectories of the University. Blueprint and Roadmap for the Future

Blueprint and Roadmap for the Future

To put the institution on a high growth trajectory for achieving excellence in teaching, research and innovations, University leadership has charted out the holistic roadmap to be pursued in the coming years.

- I. Major thrust areas that the University proposes to focus—
 - Identifying the prospective areas requiring immediate attention for creating vibrant academic and research environment and to review all the ongoing projects in the institution. Priority will be given for NAAC accreditation of the university for which the University has already submitted its Self Study Report and Letter of Intent. University is awaiting visit of the NAAC team for the first cycle of NAAC assessment for NAAC accreditation.
 - Making the website a repository of all the available information, facilities, resources and opportunities which the University offers so that the stakeholders of the University are not deprived by any barriers of geographical location while accessing the relevant information. Open educational resources (OERs), Massive Open Online Courses (MOOCs), resources under National Mission on Education through Information and Communication Technology (NME-ICT) and resources available under 'Creative Commons' license are being linked to provide vast pool of useful and supplementary material to the students. MOOCs will offer the students

- anytime-anywhere learning environment, which is becoming increasingly popular as one of the most effective tools for knowledge sharing and dissemination. The University is already registered with the National Digital Library (NDL) and all the Students and Faculty Members are provided with a login id to access the vast repository of ematerial, e-books and other OER available with NDL for enhancing their knowledge seeking experience.
- Credible open forums in the form of Cells and Clubs have been established for interaction between the teaching, learning and the non-teaching community to understand their needs, demands and aspirations for bringing about the desired change.
- Establishment of University Development Corpus Fund to create a corpus for funding, supporting, sustaining academic and research initiatives of various in-house Centres and Institutes, faculty members, research scholars and students is in process. The University has already firmed up a proposal under the aegis of Innovation Club through which it invites proposals for conducting Research and Innovations at the Grass-root levels. The corpus involves generation of funds from but not restricted to:
 - Industry
 - Alumni Endowments
 - Overhead grant from Extramural Research grants
 - Consultancy

- Patents and technology transfer
- Grant from International bodies under their social and academic initiatives
- Memorandum of Understanding with various Industry, Government and Research Institutions for collaborative efforts in developing new and innovative sustainable technologies.
- Special initiatives and programmes for differently-abled and disadvantaged students to realise the vision of inclusive quality education. All efforts shall be made to make the campus differently-abled and disadvantaged-friendly as per the requirements and guidelines of Government of India. A duly constituted Special Cell is involved in initiating affirmative action and monitoring of progress opportunity to all the students even for exploring the possibilities to create and generate employment opportunities. Grants and aid will also be provided to deserving students for enhancing their employability skills.
- Equal Opportunity Cell is ensuring that all sections of the students are provided appropriate support and special initiatives are undertaken for bringing students of the backward and underprivileged sections at par with others by offering them a level playing field for competition. For this Special Remedial Classes, Coaching Classes for NET and entry into Services are organized by the Cell.
- II Empowering and strengthening the existing University system:-
- E-Governance: To bring the entire functioning

- of the University under the ambit of e-Governance, the University shall expedite the digitization process. The entire university is being linked through internet so that all the schools, departments and centres will be on a common network.
- Transforming education system for creating exciting opportunities- Choice-Based Credit System (CBCS)
 - Shift in focus from teacher-centric to student-centric education.
 - Allows students to choose innovative curriculum through inter-disciplinary, intra-disciplinary courses, skill oriented papers, vocational education and encourages more flexibility for students.
 - Makes education broad-based and at par with global standards
 - Ease of mobility for students
 - Faculty Development Programmes: Creating opportunities for the faculty to get oriented to latest innovative pedagogies, research methodology and professional skills by providing training through induction courses/workshops and seminars at regular intervals.
 - School/Department development programmes: Enriching state of the art labs with more equipment and securing funds from various Government of India schemes for creating department-centric research facilities and developing Learning Resource Centres.
 - New learning and teaching pedagogy initiatives: Developing e-learning material and MOOCs to facilitate anytime-

- anywhere learning mode for the students and provide them with better learning opportunities for enhancing their knowledge gathering experience.
- Modernisation of the Library: Library is the temple of wisdom and knowledge in a university. Apart from acquiring new and existing titles and increasing the subscription of journals, one of the key features is that the library has been linked to the National grid and NDL so that access to all the e-resources including Research Thesis and e-journals and e-books that are subscribed through INFLIBNET and its affiliated universities and institutes are also available to the university students. This will also result in saving precious national resources. Further University Library and Department/School Libraries will be linked through the university intranet so that there is seamless flow of knowledge.
- Placement Opportunities: The placement cell has been refurbished and a mega University Placement Cell has been set up which is coordinating all placement related activities at the University, School and Department level so that coordinated and concerted efforts are made to bring maximum number of students under its ambit. Registration and profiling of all students in the placement cell has been made mandatory so that each student gets the opportunity to optimize their search for a career of choice and discover their true calling.
- Strengthening of Examination System: University is in the process implementing the following processes:
 - Online registration for examination

- Online issue of admission card
- Online submission of question papers
- Centralized evaluation of courses
- Decentralization of Post Graduate examination by empowering University Teaching Departments.
- Consolidation of existing departments by providing faculty with minimum required infrastructure
- Introduction of new programmes in Education, Engineering, Life Sciences, Physical Sciences, Mathematical Sciences, Performing and Fine Arts, Language and Linguistics, Pharmaceutical Sciences and Tourism & Hotel management etc.
- Introducing Certificate and Diploma courses through the schemes like B.Voc, Skills Incubation Centre and any other scheme notified by UGC, MHRD and Government from time to time.
- Priority will be given for establishing different centres under the Inter and Multi-Disciplinary format providing infrastructure and opportunity to develop and hone existing and new areas of research and innovation. These centres will act as catalysts for increasing the quality and quantity of research publication and to develop relevant and sustainable technology and obtain its patents (IPR).
- Centre for Academic Auditing: This centre will be responsible for evaluation of all academic, research and associated activities of different Departments, Centres and Institutes of the University. It will also be tasked with setting up of future benchmarks for the university.

- Technology Stock Exchange: This centre will be established with objectives like creating value for ongoing and new research or to transform research in terms of revenue. An ecosystem will be developed to provide common platform for Researchers, Industrialists, Evaluator and IPR Specialists for facilitating the improvement of incubated technologies and their transfer to industries.
- Centre for Policy and Modeling: This centre will focus in creating value in the following areas:
 - Policy for self-sustenance at macro and micro level of governance
 - Carbon footprint and Green initiatives Policy
 - Unified e-Content formulation, implementation and outreach Policy
 - Policy for reforms in Socio-Economic delivery mechanism
 - Modeling for Climate change and Weather prediction: Causes and Impact
 - Modeling for Crop prediction and associated studies
 - Modeling Studies: Use of modeling as a tool for providing real-time solutions in diverse areas ranging from drug delivery, medical profiling and genetic code generation studies, controlling traffic flows, analyzing and predicting stock market trends, etc.
- Centre for Secondary Agriculture and Energy Harvesting: Aiming at adding value to crop residue, Centre on Bioenergy & Biomaterials is proposed for developing

technologies for production of alternate fuels and biomaterials.

Energy harvesting is a new and rapidly developing concept, which strives to generate energy from everyday processes for powering low energy everyday requirements. The basic concept is to harness unproductive energy from various processes and convert it into electricity like rubbing, pressure, air friction, tidal energy, rotatory motion, body heat etc.

- Centre for Social Outreach and Management: Outreach and management programmes for society empowerment with special focus on:
 - Childcare, Health, Hygiene and Sanitation
 - Citizens' Rights and Duties
 - Self-help groups & Micro-finance cooperatives in collaboration with National Cooperatives Union of India (NCUI)
 - Training programmes for Empowerment of Women and Gender sensitization by Women Empowerment Cell
 - Conflict Resolution, Peace Studies, Legal-Aid and Counselling through Legal-Aid Clinic of the University
- Centre for Innovation, Skill, Entrepreneurship and Employment: This centre will be made into a dynamic hub to provide all solutions related to students employment. To encourage innovative thinking, incubate ideas, changing mindset and increase the employability of the students, there will be regular interactions

between the academia and the industry under the aegis of this centre. Special emphasis will be laid for developing soft skills of the students like communication, team building, leadership and domain skills. Tie-ups will be made with both public and private partners to provide vocational and entrepreneurial training to the students for setting up their own Micro, Small, Medium Enterprises (MSME's) apart from regularly organizing placement drives. Courses to be offered under the scheme of B.Voc, Deen Dayal Upadhyay KAUSHAL KENDRA and Incubation Centre for Skills (in collaboration with NSIC) shall be instrumental in achieving these objectives. In the ever-changing realm of education there is an increasing need to start vocational courses which directly cater to skills and vocations which do not form part of standard undergraduate and postgraduate courses.

Instrumentation and Analytical **Techniques:** Instrumentation is a rapidly growing field in India. There is huge potential in this field as India gears up to provide quality and cost effective alternatives to expensive imported instrumentation that is currently available in the market. Analytical Techniques and their applications cover a wide spectrum of disciplines ranging from Life Sciences, Physical Sciences and Material Sciences providing cutting edge solutions particularly in research areas. University has already entered into MOU with Technology Applications Services (TAS), New Delhi and Central Electronics Engineering Research Institute (CEERI), Pilani to facilitate the same.

- Courses on Diagnostics: Diagnostic techniques require the user/learner to have a broad based knowledge, which is inter-disciplinary and multi-disciplinary in nature. The courses on diagnostics will seek to bridge the gap between the knowledge and skills required and those available in the existing courses by offering a course dealing with all the aspects of Diagnostics.
- New courses for Media Studies, Technical Writing and Editing: The realm of Media Studies is ever expanding as new and innovative forms of engagement with the public take shape. Existing Media studies courses in audio, visual, electronic and print media and multimedia are mostly conducted by private institutes at prohibitive costs. These courses will try to provide such knowledge and skills at affordable cost and also aim to explore relatively niche fields of technical writing, editing and multimedia in Science and technology.
- Centre for Culture and Heritage:
 University has introduce the Centre for
 Culture and Heritage to facilitate the studies
 and researches in the field of Culture
 Studies, Indigenous Studies and studies on
 indigenous arts, culture and heritage.
 Besides, this centre will be dedicated to
 preserving folk arts, music and literatures.

III. Self-sustaining Initiatives:-

 Developing crucibles of learning and development: Motivating staff and students to develop models, experiments, technologies to catalyze local/ regional/ national growth and development in association with local industry/trade/

handicrafts/vocations.

- **Solid Waste Management:** Initiatives for solid waste management will be undertaken so that the university becomes a zero-waste university. Options will be explored for utilizing the waste to create energy and other productive materials. A B.Voc. course has been launched in the field of Industrial Waste Management.
- **E-Waste management:** E-waste is increasingly becoming an environmental disaster and processes will be put in place to recycle and effectively dispose the e-waste that is generated by the university.
- Energy generation: Setting up of solar street lamps, solar panels on university building's rooftops and designing of new buildings on the concept of zero-energy/green buildings.
- Rain-water harvesting: A feasibility study is being conducted to implement rain-water harvesting so that university is able to meet at-least part equipment of water from its own sources. Rain-water harvesting is already being practiced by the University at micro-level.
- Sports Academy: Since the university has ample land available with it, hence part of that land will be utilized in setting up a sports academy for creating world-class infrastructure for students. This facility will also be leased out/ memberships provided so that the academy also earns revenue for the university. Moreover, special emphasis will be given to establishing sports facility for disabled persons.
- **Organic Farming:** Keeping in mind the vast

expanse of land available with the university, an organic farm will be set up and the produce may be sold at the local/regional markets to earn some revenue for the university. Moreover, it could be used for training the students and for demonstration purpose for the local population. A small model organic farm has already been established in the University.

• **Solar Power Plant:** University proposes to establish solar power generation plant as a sustainable means to generate eco-friendly and cost-effective energy and become energy self-sufficient.

IV Possible challenges and proposed steps to overcome the roadblocks:-

- Digitisation and proper designing of the website will pose the problems like: What should be the structure, content, look and feel of the website?
 - For this, efforts will be made to either recruit a capable team to handle the website or to outsource it to some experienced agency. Cost effectiveness, quality, efficiency and confidentiality will be key factors in decisions related to website. At present the website development and delivery is being done by INFLIBNET.
- For setting up of University Development Corpus Fund, the Acts and Statues of University will have to be studied carefully to avoid any deviations.
 - The office of the Registrar, Finance Officer and Legal Advisor will be tasked to formulate the policies, guidelines and rules and regulations in accordance with the Acts and Statutes of the University and the rules

for financial transaction of Government of India.

 Identification of areas of affirmative action will be a challenge, as this would involve collecting information from all components of the university with all possible suggestions for such areas.

Setting up of an empowered committee to execute this entire plan, roadblocks are being removed at the earliest.

 The biggest challenge for implementing examination reforms will be to orient and sensitise the teaching, learning and nonteaching community particularly regarding the provisions of Choice-Based Credit System (CBCS).

For this, workshops will be organized to educate and sensitize all the stakeholders regarding the benefits of an efficient and credible examination system and launching of new courses/programmes.

 Providing appropriate directions to the departments / centres regarding research funding and funding agencies.

> The University leadership will use its longstanding experience in handling various research projects granted from different funding agencies under different Departments of the Government of India to ensure that funding is made available to these centres. Further efforts will be made to

bring experts and people of eminence in their respective fields to head/advise the existing departments and new departments & centres for providing proper direction.

Sometimes, the constraint with public universities is that though they have the best talent but due to lack of proper advertising and publicity they do not attract best recruiters with good job profiles. Also funding for student welfare initiatives may sometimes pose a constraint.

Some funds will be set aside for proper visibility and special funds will be created for imparting vocational and entrepreneurial training at a nominal cost. Sponsorships will be sought for conducting placement drives smoothly.

The University has started the construction work of the second phase and the work on academic blocks, staff quarters and administrative block is in full swing. It is hoped that the new Academic Session will see the University Departments moving to the new buildings. Development of Central Library, Students Activity Centre and Guest Houses are to be taken up on priority.

University

The Prime Minister of India, in his address to the nation on August 15, 2007, announced the establishment of one Central University in each of the states that did not have a central university. Subsequently, the Central Universities Act 2009 (No. 25 of 2009) provided for the establishment of Central University of Haryana as one of the new Central Universities. The University is funded and regulated by the University Grants Commission (UGC) and Ministry of Human Resources Development, Government of India. Its territorial jurisdiction extends to the whole State of Haryana.

The President of India, His Excellency Shri Pranab Mukherjee, is the Visitor of the University.

The Chancellor

Prof. (Dr.) M.P. Singh is the Chancellor of Central University of Haryana. He was appointed as Chancellor by the Visitor of the University, Her Excellency Smt. Pratibha Devi Singh Patil, the former President of India.

Vice Chancellor

Prof. R.C. Kuhad is the Vice Chancellor of Central University of Haryana. He was appointed as Vice Chancellor by His Excellency Shri Pranab Mukherjee, the President of India, in his capacity as the Visitor of the University.

Permanent Site for the University

Central University of Haryana is located at Jant-Pali villages of district Mahendergarh in South Haryana. Mahendergarh is now a part of the extended National Capital Region (NCR) and is around 150 kilometres away from Delhi. It is well connected to Delhi through railways. The nearest railway station is 13 kilometres away from the Campus. District headquarter of the Mahendergarh district is situated at Narnaul.

The University is starting two new courses namely B.Ed. and M.Ed. under the Department of Education. University is also in the process of opening School of Engineering by starting four Engineering courses, approval for which has been granted by the UGC.

ABOUT MAHENDERGARH, HARYANA

The Central University of Haryana is located at Jant-Pali villages of district Mahendergarh in South Haryana. Mahendergarh is now a part of the extended National Capital Region (NCR) is around 135 kilometers away from Delhi. It is well connected to Delhi by road and railways. The headquarter of the Mahendergarh district is situated at Narnaul.

Mahendragarh was earlier known as 'Kanaud' because of its association with Kanaudia group of Brahmans. During the middle of the nineteenth century, it came to be known as Mahendergarh. After India achieved Independence, the Mahendergarh district along-with the other districts of the Patiala State formed part of the Patiala and East Punjab State Union (Pepsu in 1948) merged with Punjab in 1956. When Haryana became a separate state being carved out of Punjab in 1966, Mahendragarh became one of the districts of the new state.

The name of Haryana instantly conjures up the image of a State which astonishingly combines both antiquity and plenty. The Vedic land of Haryana has been a cradle of Indian culture and civilization. Indian traditions regard this region as the matrix of creation of northern altar where Brahma performed the pristine sacrifice and created the universe. Replete with myths, legends and Vedic references, Haryana's past is steeped in glory. It was on this soil that saint Ved Vyas wrote Mahabharata. It was here, 5,000 years ago, that Lord Krishna preached the gospel of duty to Arjuna at the onset of the great battle of Mahabharata:"Your right is to do your duty and not to bother about the fruits (Outcome) thereof!" Since then, this philosophy of the supremacy of duty has become a beacon to succeeding generations.

The region has been the scene of many wars because of it being 'A Gateway to North India'. As

years rolled by, successive streams of the Huns, the Turks and the Tughlaqs invaded India and decisive battles were fought on this land. At the end of the 14 century, Tamur led an army through this area to Delhi. Later, the Mughals defeated the Lodhis in the historic battle of Panipat in the year 1526. Another decisive battle was fought in the year 1556 at this very site, establishing the supremacy of the Mughals for centuries to come.

The history of Haryana is the saga of the struggle of a virile, righteous, forthright and proud people. From ancient times, the people of Haryana have borne the main brunt of invaders and foreign hordes with their known traits of bravery and valour. Central Universities' Common Entrance Test (CUCET)-2016

THE CUCET-2016 Examination: The Central Universities' Common Entrance Test-2016 (CUCET-2016) is conducted jointly by nine Central Universities, namely, Central University of Haryana, Central University of Jammu, Central University of Jharkhand, Central University of Kashmir, Central University of Karnataka, Central University of Kerala, Central University of Punjab, Central University of Rajasthan and Central University of Tamil Nadu. This test is conducted for the students of 10+2, Bachelor Degree holders and Master Degree holders to obtain admission to the UG / Integrated Program, Post-Graduate Programme and the Research Programme respectively in these nine Central Universities.

A candidate shall be eligible for admission to M.Phil Programme, if he/she:

- (i) Has qualified Master's Degree in the subject concerned / allied/cognate subjects with at least 55% marks, in aggregate from the University and/or a degree recognized by the University for this purpose as its equivalent.
- (ii) The cases of students who have passed examination outside the Indian Universities system and who may not have obtained a Master's degree may be considered for admission to the programme subject to the condition that each case shall be examined on its own merit by the Admission Committee and in accordance with recommendations of the Equivalence Committee.

Note: The candidates shall appear in CUCET followed by interview to be conducted by the concerned department which shall carry weightage of 80% and 20% respectively. Candidates who have cleared NET/JRF/SET/Teacher Fellowship or who have teaching/research experience of more than two years on regular basis shall be exempted from the written test. In such cases the interview shall carry 100% weightage.

For All Ph.D. Programmes except Ph.D. in School of Interdisciplinary and Applied Life Sciences

A candidate shall be eligible for admission to the Ph.D. programme, if he/she has qualified Master's Degree in the subject concerned / allied / cognate subjects with at least 55% marks in aggregate.

REGISTRATION IN COURSES

1. PG Programme

- a. Registration of courses is the sole responsibility of a student. No student shall be allowed to do a course without registration, and no student shall be entitled to any credits in the course unless he/she has been formally registered for the course by the scheduled date fixed by the University.
- b. Every student has to register in each semester (in consultation with his/her Student Advisor) for the courses he/she intends to undergo in that semester by applying in the prescribed proforma in triplicate, duly signed by him/her, the Student Advisor and the Head of the Department, within the deadline notified for the purpose by the University.
- c. Late registration may be permitted by the Dean of the faculty up to a maximum of two weeks after the commencement of the semester on payment of prescribed late registration fee.
- d. A student shall register for a minimum of 15 credits and can register for a maximum of

- 24 credits in a semester, unless it is specified otherwise by the University for a Programme of study/course.
- e. Withdrawal from a course shall be permitted up to two weeks from the date of registration, provided the courses registered after withdrawal shall enable the student to earn a minimum of 15 credits. Withdrawal from a course shall not be allowed for those who had late registration.
- f. A student shall be allowed to add a course or substitute a course for another course of the same type (core, elective or self study/skillbased) for valid reasons with the consent of the Student Advisor not later than two weeks from the date of commencement of the semester.
- g. If a student registers for more elective courses than prescribed in the programme, while calculating the Semester/Cumulative Grade Point Average only the prescribed number of elective courses prescribed for the programme of study shall be included in the descending order of the grades obtained by him/her.

- 2. M.Phil. Programme: Every student has to register in the first semester (in consultation with his/her Student Advisor) for the course work by applying in the prescribed proforma in triplicate, duly signed by him/her, the Student Advisor and the Head of the Department, within the deadline notified for the purpose by the University.
- **3. Ph.D. Programme:** A student who is not exempted from Course Work and for whom prerequisite courses are prescribed shall be required to clear the course work within the first semester. The registration of such students shall be confirmed only if he/she has secured 20 credits and a minimum CGPA of 6.5 (6.00 in case of SC/ST/Differently abled students). For the candidates exempted from Course Work, the concerned department shall

recommend the registration on the basis of the periodical presentations/assignments or seminars delivered by them during the first semester of their admission.

EVALUATION PROCESS

Evaluation Process and Examination for PG Programmes

The students seeking admission in Post-Graduate programmes will be governed by the Examination Ordinance for Post-Graduate Programmes as notified by the University from time to time. For further details regarding the Examination Ordinance for Post-Graduate Programmes the students are advised to visit the University website.

ADMISSION RULES AND RESERVATION POLICY

Admission rules to be followed for admission to various programmes of study of the University are given below:

1. ADMISSION COMMITTEE

- I) There will be an Admission Committee in each department consisting of the following which will be responsible for making admissions to the respective department in accordance with the University rules:
 - a) Head of the Department /Teacher In Charge Convener
 - b) Three teachers to be nominated by the Head of the Department
 - c) One representative (teacher) belonging to the SC/ST/OBC/PWD/Woman from any department if any of the members does not belong to any of these categories.
- II) Each Department will be responsible for performing all admission related work of the Department.
- III)There will be a Standing Committee (Admissions), consisting of the following which will make recommendations to the Academic Council/Vice Chancellor on issues concerning

Admission Policies, eligibility criteria and other related issues referred to it:

- a) One of the Deans to be nominated by Vice Chancellor - Chairman
- b) Deans of all the Schools
- c) Two Members of Academic Council nominated by the Vice Chancellor
- d) Proctor
- e) Dean Students' Welfare (DSW)
- f) Heads of the concerned Departments whose matter/s are listed on the agenda
- g) One representative of SC/ST/OBC/PWD /Woman if any of the members does not belong to any of these categories.

2. AGE

There will be no minimum or maximum age bar for admission to any programme of study in the University except in the courses where the respective regulatory bodies (such as Medical Council of India (MCI), Dental Council of India (DCI), Bar Council of India (BCI), National Council for Teacher Education (NCTE), All India Council of Technical Education (AICTE) etc.) have prescribed any such rule in this regard.

3. Relaxations And Concessions

(a) Scheduled Cast/Scheduled Tribe (SC/ST)

- i) The minimum eligibility requirement for the Scheduled Caste/Scheduled Tribe candidates will be that they must have passed the qualifying school degree examination. Provided that the minimum eligibility for admission to post-graduate programmes be the minimum pass marks of the qualifying examination concerned of the Central University of Haryana or the marks should not be less than 40%
- ii) Where the admission is based on screening/written test, the Scheduled Cast/Tribe candidates would also be required to take the test but their merit list will be drawn separately.
- iii) However, for admission to M.Phil. and Ph.D. Programmes, the SC/ST candidates shall be given only 5% relaxation in the minimum eligibility marks.

(b) Other Backward Classes (OBC)

i) The OBC candidates shall be given a relaxation in the minimum eligibility in the qualifying examination and in the minimum eligibility (if any) in the admission entrance test to the extent of 10% of the minimum eligibility marks prescribed for the General Category candidates. For example, if the minimum eligibility for admission to a programme is 50% for the General Category candidates,

the minimum eligibility for the OBCs would be 45% i.e. (50% less 10% of 50%.)

- ii) All those OBC candidates who meet the minimum eligibility marks in the qualifying examination and the minimum eligibility marks (if any) in the entrance test shall be eligible for admission in the order of their merit. keeping in view the availability of seats reserved for them.
- iii) The OBC candidates who belong to the 'Non-Creamy Layer' and whose castes appear in the Central List of the OBCs only shall be eligible to be considered for admission under the OBC Category.

c) Person With Disabilities (PWD)

The PWD candidates with not less than 40% disability shall be given a relaxation in the minimum eligibility in the qualifying examination and in the minimum eligibility (if any) in the admission entrance test to the extent of 5%.

(d) Children/Widows of the eligible Armed Forces Personnel (CW Category)

A concession of 5% marks in the minimum eligibility requirements in the qualifying examinations will be given to these candidates.

(e) The candidates belonging to the Scheduled Caste-Scheduled Tribe and Persons with Physical Disability shall be charged the admission form/entrance examination fee at concessional rates.

4. RESERVATIONS

(a) Scheduled Caste/Scheduled Tribe/Other Backward Classes

i) Reservation of seats in admissions to various programmes of study shall be in

the following manner:

Scheduled Caste = 15% of total intake in each programme

Scheduled Tribe = 7.5% of total intake in each programme

Other Backward Class = 27% of total intake in each programme

- ii) The seats reserved for the SC/ST shall be filled by the SC/ST candidates only. However, in the case of non-availability of the eligible candidates the reserved seats may be interchanged between the SC & ST. If still any seat remains unfilled due to non-availability of eligible candidates of either Scheduled Caste or Scheduled Tribe or both may be thrown open to the general category in that year provided this has been notified to the National Commission for Scheduled Caste /Tribes, University Grants Commission and the Ministry of Human Resource Development and concurrence has been obtained, failing which the seat will be left vacant.
- iii) The seats reserved for the OBCs shall be filled with the OBC candidates only. Only if OBC candidates possessing the minimum eligibility marks are not available in the OBC category then the vacant OBC seats shall be converted into General Category seats in accordance to the admission schedule notified by the University.

(b) Supernumerary seats:

(i) Persons With Disabilities (PWD) = 3% of total intake in each programme shall be reserved for the PWD (1% each for the persons with low vision or blindness, hearing impaired and loco motor disability or cerebral palsy (interchangeable in case of non-availability of candidates in the

subcategories).

(ii) Children/widows of the eligible Armed Forces Personnel

(CW Category) = 5% of the seats in each programme shall be reserved for these candidates.

Admission of candidates belonging to CW categories shall be made in the following order of priorities:

- (i) Widows/Wards of Defence personnel killed in action;
- (ii) Wards of serving personnel and exservicemen disabled in action;
- (iii) Widows/Wards of Defence personnel who died in peace time with death attributable to military service;
- (iv) Wards of Defence personnel disabled in peace time with disability attributable to the military service; and
- (v) Wards of Ex-servicemen personnel/ serving personnel including personnel of police of forces who are in receipt of Gallantry Awards;

Category-V Gallantry Awards include: Param Vir Chakra, Ashok Chakra, Sarvottam Yudh Seva Medal, Maha Vir Chakra, Kirti Chakra, Uttam Yudh Seva Medal, Vir Chakra, Shaurya Chakra, Yudh Seva Medal, Sena, Nau Sen, & Vayusena Medal, Mention-in-Despatches, President's Police Medal for Gallantry, Police Medal for Gallantry

- (iii) Foreign Nationals: 5% seats in each programme in each Department.
- (iv) Sports/Extra Curricular Activities (ECA)

a) For undergraduate courses:

Sports/ECA Persons: Upto 5% of intake in each undergraduate programme may be offered to the candidates on the basis of Sports and ECA on the recommendations of a Committee consisting of the following:

- 1. Dean of the concerned School-Chairman
- 2. Head of the concerned Department
- 3. One External Expert to be nominated by the Vice Chancellor
- 4. Director, Physical Education
- 5. Dean Students' Welfare (Convener)

b) For postgraduate courses:

Sports: Upto 5% of total intake in each postgraduate programmes may be offered to the candidates on the basis of Sports on the recommendations of the Committee constituted under Clause (a) above.

5. Permission to students to apply under General/SC/ST/OBC Category as well as CW/PWD Category etc.

The candidates applying for admission to various courses shall be permitted to apply simultaneously under Gen/SC/ST/OBC Category as well as Children of War Widows, Person with Disability and other categories for which reservation/concession is admissible. The application from should, therefore, contain appropriate columns for mentioning such categories.

6. Registration/Admission of foreign nationals

i) The foreign nationals seeking admission in

the University shall have to get themselves registered with the office of the Dean Students' Welfare (DSW) in compliance with the schedule notified by the University. No Foreign student will be admitted directly by any Department / School. They will be registered only on the recommendations of their respective High Commission Embassies.

- ii) Foreign nationals shall be exempted from appearing in Admission Entrance Test conducted for admission to various Under-Graduate and Post-Graduate programmes including Professional Courses. Foreign nationals who are stationed in India and have passed their last examination from Board/University in India shall also be exempted from appearing in entrance test.
- iii) All the categories of foreign students shall come under the same category of 5% quota for foreign nationals for admission to various programmes. This shall include foreign nationals with qualifications attained either from Indian Board/University or Foreign Board/University.
- iv) All admissions in Foreign Students' category shall be done on individual merit and a single merit list of foreign students, both with Indian and foreign qualifications shall be prepared for admission in various programmes.
- v) At least one seat shall be reserved for foreign nationals in all the programmes wherever the total numbers of seats for admission is less than 20.
- vi) Foreign Nationals admitted to the Central University of Haryana will be required to get medical insurance which is mandatory.
- vii) The foreign students shall have to pay annual fee at the following rates:
 - a. Postgraduate/Master's programmes excluding professional programmes 1200 US Dollars

- b. All Professional programmes 1350 US Dollars
- c. M.Phil./Ph.D.

1500 US Dollars

d. Undergraduate programmes

1050 US Dollars

The above fee does not include hostel/mess fee.

- 7. The departments if they decide to hold Group Discussion (GD) or interview in addition to the admission entrance test shall not assign more than 20% marks to the GD or interview.
- 8. The merit list for the general category seats will comprise of all the candidates in the order of merit including SC/ST/OBC, if they come under the general category merit. No one will be excluded from the same. In other words, it will also include SC/ST/OBC candidates if they come in the general merit. All such reserved category candidates shall be entitled to be considered under the general category, as well as under the reserved category. Admission to open category seats will be strictly in the order of merit without excluding SC/ST/OBC candidates.
- **9.** The details of the seats of General and reserved categories will have to be notified by the Departments concerned before beginning of the admission process.
- are based on the rank in the entrance examination, the candidates will be eligible for admission only after the result of the qualifying examination has been declared and the candidates meet the minimum eligibility criteria. However, the candidates whose results of the qualifying examinations are awaited, may be offered provisional admission, subject to submission of their

- results latest by 30th August, failing which their provisional admission will be cancelled. Such candidates shall submit an undertaking to this effect.
- 11. All admissions shall have to be finalized by the Departments in strict compliance with the schedule of admission notified by the University and in no case admission shall be allowed beyond the last date of admission.
- **12.** The Departments shall get the relevant certificates submitted for availing the benefit of reservation verified from the respective issuing authorities.
- 13. No student of the University shall be permitted to pursue two degree courses or other full time Courses simultaneously either from the Central University of Haryana or from other University except the part-time or weekend diploma/certificate Courses.
- 14. For admission to the courses which are governed by the Regulations of the regulatory bodies like Medical Council of India (MCI), Dental Council of India (DCI), Bar Council of India (BCI), National Council for Teacher Education (NCTE), All India Council of Technical Education (AICTE) etc., admissions and other rules prescribed under their respective regulations shall be followed.
- 15. In case, any information/document furnished by the candidates in their applications for admission is found to be incorrect/fake at any time after admission, the admission of such candidates shall be liable to be cancelled by the Head of the Department immediately, besides initiating other action in accordance with the University rules.

(ii) Computer Science and Engineering: No. of seats: 60

Overview: Computer Science and Engineering introduces fundamental concepts of computer science and computational thinking. It includes hardware and software aspects like logical reasoning, problem solving, data representation, abstraction, the creation of "digital artifacts" such as Web pages and programmmes, managing complexity, operation of computers and networks, effective Web searching, ethical, legal and social aspects of information technology and introduces skills, concepts, and capabilities necessary to effectively use information technology.

India's booming IT Sector (total revenues generated by the IT industry in India in 2015-16 was 119.1 billion US dollars-Source: statista.com), Government of India's initiative of 'Digital India' and 'Design in India', 'Kaushal Bharat Kushal Bharat', 'Startup India Standup India' and schemes like 'Technology Development Mission' will require trained engineering graduate students particularly in the field of Computer Science and Engineering for laying the foundation of a Digitally empowered and ICT enabled country. Also, this course will help in meeting the industry demand of trained 'Hardware' and 'Software' engineers to keep India at the forefront of Design, Software and Programming skilled manpower.

(iii) Electrical Engineering: No. of seats: 60

Overview: The electrical engineering field is built to meet the energy and

telecommunication needs of our society. Out of the advancements in electronics and photonics technology, Electrical Engineering is all around us today. Electrical engineers conduct research, and design, develop, test, and oversee the development of electric systems and the manufacture of electrical equipment and devices. From the global positioning system that can continuously provide the location of a vehicle to giant electric power generators, electrical engineers are responsible for a wide range of technologies. Some of the equipment includes broadcast and communications systems; electric motors, machinery controls, lighting, and wiring in buildings, automobiles, aircraft, and radar and navigation systems; and power generating, controlling and transmission devices used by electric utilities.

Electrical engineers can be found in almost all sectors of the work force, including research and development; product design; manufacturing, operations; real-estate; services; technical sales; marketing; consultation and education; and policy making. With the target of 100% electrification of villages by May 1st, 2018 and a budgetary allocation of Rs. 5036 crores for renewable energy sector and another Rs. 3000 crores for nuclear energy sector, apart from overall push for energy generation, this is a very challenging and exciting field to pursue. This course will provide students with a strong foundation in the traditional and contemporary areas of electrical engineering and its applications. The student should be in a position to learn fundamentals of electrical engineering to conceive and solve technological problems in society. By acquiring sufficient knowledgein the chosen field with right aptitudes and attitudes to take up any relevant job or to pursue further education.

(iv) Printing and Packaging Technology: No. of seats: 60

Overview: Printing and packaging technology is a special branch of engineering

which deals with the printing technology and packaging of the content. Packaging engineering is a broad field from design conceptualization to product placement.

The invention of "Printing Technology" changed the whole world by spreading knowledge and information to different levels. In fact the highest contribution for the development of mankind in last millennium could happen primarily through printing. In this 21st century that role is taken over by internet and information technology. That does not mean the prominence of print has come down, rather it has become much more important today by taking a complete repurposing and modern applications in packaging and other functional printing applications. Our course programme is designed to fulfill the current market requirements and the future needs. Thus in the study programme the student will learn in detail the modern printing technologies, its application knowhow and print as a micro structuring technology, functional printing and printed electronics. Print media offers students an opportunity to explore new areas of research in the graphic communications field. The curriculum focus on establishing quality and efficiencies pertaining to business, technology, and processes in graphic communications. It deals in depth on many different areas, including print, business, color management, web and IT, digital, publishing, imaging, and typography. The Engineering course is designed to cover all the aspects of Printing and Packaging which includes printing process, typography and typesetting, theory and working of printing machines, digital electronics, reproduction technology, sheet-fed offset technology, flexo, gravure, screen, inkjet, etc. will be taught in details. Electrical systems in printing machines, manufacturing process, electrical systems in printing machines/ labs, package manufacturing, package machinery manufacturing, food processing and bio-processing, packaging for user industries like food, pharmaceutical products, cosmetics, electronics, transportation, chemicals, radioactive and hazardous goods and materials, consumer goods, heavy machinery, earth moving

equipment, container packaging and others will be covered to provide in depth and comprehensive knowledge. An important aspect of the Packaging technology is testing of various types of packaging to ensure that the requirements and needs of the products are well taken care of.

Since conventional print has lot to do with packaging science and engineering, equal importance is given to packaging science in the study programme. In India there is a huge scope for the growth of packaging. The Indian packaging industry is one of the fastest growing industries clocking an annual growth rate of more than 15 per cent in 2015-16 and is valued at \$ 15.6 billion (Source: packplus.in-PackPlus 2016). Packaging is part of the product that in many ways, positively or negatively, affects its sales. It also allows, due to the advancement of techniques and technology, a quick adjustment to the market and consumer needs. With a professional and rational selection of technologies and type of packaging material, substantial savings can be brought to manufacturers, retailers, and consumers. The choice of technology and process equipment, the selection of equipment for packaging, construction, technical and graphic design of the packaging, labeling and marking of products in accordance with regulations of the Govt. of India and the world as a whole. Coding, the optimization of packaging, logistics of packaging, the choice of optimal packaging materials, selection of packaging equipment, proposing of innovative solutions, the selection of alternative packaging materials to reduce costs, production of technical and technological documentation including technical drawings, specification of packaging.

In India, very few Institutes and Colleges offer this course and there is a very high demand of skilled and trained workforce in this field particularly in order to ensure that there is minimum wastage due to damage, degradation or spoilage. Also, with India aspiring to be global manufacturing hub, Printing and Packaging Technology is a key area that can have significant impact in realization of desired goals.



GUIDELINES FOR REGISTRATION

The candidates who obtained 50% marks in qualifying examination (10+2) or equivalent grade (for SC/ST/PWD/OBC non-creamy layer 45% marks) from CBSE or any equivalent Board and who appeared in JEE (mains) need apply for admission to B.Tech. (Civil Engg.), B.Tech. (Computer Sc. & Engg.), B.Tech. (Electrical Engg.), B.Tech. (Printing & Packaging Tech.) in CUH.

- 1. The registration for B.Tech. admission is to be made by filling the registration form on-line.
- 2. Besides the personal details such as Name, Father's Name, Mother's Name, Date of Birth, Qualifying Examination, Name of Board, Percentage of marks, the candidate is required to fill up the Roll No. of JEE (Mains), JEE (Mains) Score, also.
- 3. Registration fee of Rs. 1000/- (for SC/ST/PWD it is Rs. 500/-) to be remitted in the form of Bank D.D. The details of DD (Name of Bank, DD No., and amount) are to be filled on-line in Registration form.
- 4. There are FOUR preferences for B.Tech. which are required to be filled in order of priority. In each preference there are four drop down discipline options viz.: Civil Engineering, Computer Science and Engineering, Electrical Engineering, Printing & Packaging Technology, out of which, candidate is to select one for each preference separately.
- 5. After submission of the Registration form on-line, its printout is to be taken as hard copy. Passport size photograph is to be pasted on right top corner of the form which is to be signed by the candidate at the end with date.
- 6. Photocopies of matriculation and qualifying examination must also be attached with the form before sending it to CUH. The above printout with photograph along with D.D. drawn in favour of The Registrar be inserted in envelope and sealed. On top of the sealed envelope "B.Tech Registration Form" be written. It is to be sent to the following address by Registered/Speed Post so as to reach CUH latest by 19-08-2016.

GUIDELINES FOR COUNSELING

- 1. Following the recommendations of the committee which finalized scheme and syllabi of B.Tech. courses, the admission to B.Tech. (Courses) is to be made on the basis of valid JEE (Mains) Score.
- 2. Every candidate is required to be present personally in counseling for admission as per schedule notified. No exemption will be granted from physical presence of candidate during counseling except in exceptional cases where the candidate is hospitalized, his/her parent/guardian may be allowed during counseling. In this case, the parent/guardian should bring medical certificate of hospitalization of their ward from Medical Officer/CMO from any Govt. Hospital and authorization letter from their ward (i.e. candidate).
- 3. The admission to the eligible candidate (have minimum 50% marks in qualifying examination for SC/ST/PWD/OBC noncreamy layer it is 45%) will be made on the basis of merit of valid JEE (mains) score during the counseling as per schedule notified. In case two or more candidates have identical JEE (mains) score then the merit will be decided on the basis of JEE rank. In case two or more candidates have the same rank then the merit will be decided on the basis of seniority in age.
- 4. The branch (Civil, Computer Sc. & Engg., Electrical, Printing & Packaging Tech) will be allotted at the time of counseling on the basis of JEE (Mains) score vis-a-vis preference exercised by the candidate.
- 5. The candidate is required to deposit fee of Rs. 60137/+Rs. 5000/ as Security (refundable- one time) as per schedule and fee structure to be notified. (For SC/ST tuition fee is exempted).
- 6. The Hostel admission is to be made for admitted interested students on the merit of JEE (Mains) Score for which Hostel admission form is to be filled in at the time of admission and Hostel fee to be deposited in Hostel.

SPECIAL FEATURES OF THE CUH CAMPUS

With the completion of the first phase construction, University shifted to the Permanent Campus in August 2013 and the construction work of second phase is nearing completion. Construction work of second phase includes development of whole campus keeping in view the following:

- · Approximately 500 acres of campus
- · About 80% area is green/open area
- Concepts of Green Building, Photovoltaic roof structures and solar trees for harnessing solar energy to guide the campus development
- Campus to be developed in phases each phase linked to the idea of an integrated Campus, housing 'State of the Art' buildings environment friendly and energy efficient
- Such building materials has been selected that minimizes any detrimental environmental effects
- Construction items would include locally available bricks, concrete, steel etc. with high levels of re-cycled contents
- Buildings of the University will be constructed in a cost effective manner
- Passive solar design for natural heating and cooling.
- To optimize heat and AC system:
 - Trees, vegetation and bird habitat on the site will be protected during the construction of campus buildings
 - Creating the water harvesting projects and lakes within the Campus for restoring the rain water and maintaining the ground water table in the area; and to

- develop the most natural ambience to attract the birds of rare species from across the boundaries for advanced researches in flora and fauna within the campus
- Buildings to be designed keeping in view the climatic, geographic and other needs of the region
- Rain water harvesting, storing solar energy important aspect of development plan.
- Development of Campus to be in the ratio of 30: 70 (constructed: open space)
- Campus to comprise nodes designed to suit specific requirement of different schools, giving each a distinguished identity
- Core Campus will house academic nodes, laboratories, libraries core to be surrounded by periphery housing administrative block, examination wing, learning space, health centre etc. There will be pathways for pedestals to walk from periphery to core campus
- Entire Campus to be e-connected, Labs, libraries and other buildings to be fully security proof
- Knowledge corridors to connect various nodes, pathways, administrative block and residential zones
- Sports Stadium, Complex and Auditorium





POLICY ABOUT CURBING THE MENACE OF RAGGING

The University considers the menace of ragging as one of the worst forms of human rights violation and shall strictly adhere to UGC regulations on curbing the menace of ragging. The regulations are available on University Website: www.cuh.ac.in or alternatively these regulations can also be found on UGC website: www.ugc.ac.in

The objectives of these Regulations are:

- To prohibit any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student
- To eliminate ragging in all its forms from universities, deemed universities and other higher educational institutions in the country by prohibiting it under these Regulations, preventing its occurrence and punishing those who indulge in ragging as provided for in these Regulations and the appropriate law in force

What constitutes 'ragging'?

One or more of the following acts constitutes 'ragging':

 a. any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student

- b. indulging in rowdy or indisciplined activities
 by any student or students which causes or
 is likely to cause annoyance, hardship,
 physical or psychological harm or to raise
 fear or apprehension thereof in any fresher
 or any other student
- c. asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student
- d. any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher
- e. exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students
- f. any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students
- g. any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person
- h. any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student
- i. any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student

SENSITIZATION, PREVENTION AND REDRESSAL OF SEXUAL HARASSMENT

(In Compliance with Section 28 (n) of the Act)

The Central University of Haryana shall be committed to the elimination of all forms of discrimination against women and shall take proactive steps towards gender sensitisation and elimination of sexual harassment. Sexual harassment shall include such unwelcome sexual behaviour (whether directly or by implication) as:

- (a) Unwanted physical contact and advances;
- (b) A demand or request for sexual favour;
- (c) Making a sexually-coloured remark;
- (d) Exhibiting/displaying/showing pornography; and/or
- (e) Any other unwelcome physical, verbal or non-verbal conduct of sexual nature.

The aggrieved party may lodge complaint of sexual harassment, either in writing or orally, directly to the Vice-Chancellor, or to the Chairperson or to any Member of the Complaint Committee. The enquiry shall be conducted under the rules and procedures and shall be in conformity with the principles of natural justice. The formal enquiry shall commence within a week and shall be completed within two months from the date of its reference. If the UCC (University Complaint Committee) finds it impractical to dispose off the case within the given time, it shall be recorded in writing, and the period may be extended by the Vice Chancellor.

Disciplinary Action

Depending upon the severity of the case, the University Complaint Committee may

- a) (In the case of employees of the University), recommend disciplinary action including penalty and punishment as per university rules;
- b) (In the case of outsiders/service providers to the University), request the university authorities to initiate necessary action for lodging complaint with the appropriate authorities; and
- c) (In the case of students), ensue the penalty, punishment and disciplinary action against the offender which may include:
- (i) Warning
- (ii) Written apology
- (iii) Fine in cash
- (iv) Bond of good behaviour
- (v) Debarring entry into the hostel/campus
- (vi) Withholding the examination results
- (vii) Expulsion from the university
- (viii) Denial of re-admission

Jurisdiction: All members of staff; teaching and non-teaching and all students, service providers to University and outsiders are subject to the Jurisdiction of this Ordinance. The territorial jurisdiction of the Apex Committee and UCC shall extend to acts of sexual harassment in the Central University of Haryana Campus.
